BOARD MINUTES
MAY 5, 2025

- 1. Call to Order:** The Stanford Township meeting was called to order at 6:00 pm by Chairman Loren Daudt.
- 2. Roll Call:** Present were Chairman Loren Daudt, Supervisor's Wayne Anderson and Scott Johnson, Maintenance Supervisor Kevin Springer, Treasurer Brenda Springer and Clerk Barb Vogtlin.
- 3. Adopt Agenda:** Motion by Wayne second Scott to adopt the May 5, 2025 Township Agenda. Loren approved the motion.
- 4. Approve Minutes:** Motion by Wayne second Scott to approve the April 7, 2025 Township Minutes. Loren approved the motion.
- 5. Treasurer's Report:** Brenda read the Treasurer's Report as follows: Balance as of April 1, 2025 \$376,612.30; Receipts \$296.83; Void Check Plaisted Companies #11350 \$1,685.70; Interest \$560.54; Disbursements \$28,530.12; ending balance as of April 30, 2025 \$350,625.25. Security Bank & Trust Savings Account \$8,777.65; Interest \$6.13; ending balance \$8,783.78. Escrow Fund MG & D Properties, LLC \$85,656.90; Escrow Fund Isanti Sportsman Club \$4,000.00. Motion by Scott second Wayne to approve the Treasurer's Report. Loren approved the motion.
- 6. Commissioner's Report:** County Commissioner Todd Christianson said on May 6, 2025 there will be a meeting regarding Poll Pads for Elections. Scott asked about the cost. Wayne said he checked into them, and he doesn't think they are hackable.
- 7. Meeting Open to Public:** The residents from Lily Street regarding the Event Center were present. The residents have not changed their mind regarding this issue. The County apparently told the residents to come to the Township. Wayne said the road is the issue the Township has. Wayne said he did talk to the Township Attorney. Wayne also stated that the County set a precedence by allowing 6 Event Centers already. Also, there is money in the Building Permit for the County. They also asked about the business that already exists there. Wayne said that's a county issue. Jim Jensen said there are about 7 farmers with crops and horses in that area.

Beaver Dam: Mrs. Dornfeld asked what the risk was of leaving the dam there. She said she saw Todd Rubey taking dirt from their property. She also stated there is wetland all around. The water is flowing, she said. Todd Rubey will have Joe the ditch guy from Isanti County come and look at it. Wayne said Craig Willis will have to come and look at it also.
