

**STANFORD TOWNSHIP
BOARD MINUTES
JUNE 2, 2025**

- 1. Call to Order:** The Stanford Township meeting was called to order at 6:00 pm by Chairman Loren Daudt.
- 2. Roll Call:** Present were Chairman Loren Daudt, Supervisor's Wayne Anderson and Scott Johnson, Maintenance Supervisor Kevin Springer, Treasurer Brenda Springer, and Clerk Barb Vogtlin
- 3. Adopt Agenda:** Motion by Scott second Wayne to adopt the June 2, 2025 Township Agenda. Loren approved the motion.
- 4. Approve Minutes:** Motion by Scott second Wayne to approve the May 5, 2025 Township Minutes. Loren approved the motion.
- 5. Treasurer's Report:** Brenda read the Treasurer's Report as follows: Balance as of May 1, 2025 \$350,625.25; Receipts \$3,010.65; Void Check #11390 \$3,500.00 and Check #11378 \$58.04; Interest \$523.56; Disbursements \$36,305.62; ending balance as of May 31, 2025 \$321,411.88. Security Bank & Trust Savings Account \$8,783.78; Interest \$6.14; ending balance \$7,789.92. Escrow Fund MG & D Properties LLC \$85,656.90; Isanti Sportsman Club \$4,000.00. Motion by Wayne second Scott to approve the Treasurer's Report.
- 6. Commissioner's Report:** None.
- 7. Asphalt Bids:** The Township received Asphalt Bids from Rum River Contracting and Seal Tech. The bid results are as follows:

Motion by Wayne second Scott to approve both Companies for the paving. Rum River Contracting for Tulip Street and Sullivan Woods Trail, and Seal Tech for Rabbit Trail and Lily Street. Loren approved the motion.

- 8. Meeting Open to Public:** Todd Rubey was present regarding the beaver dam. Mrs. Dornfeld said she had talked to a lot of different people today at the Isanti County Government Center. She said in her research the Township gave them until the 23rd of May. She wants to know about the easement. Wayne said this issue is mainly concerning the road. Our Township Attorney will have to deal with this. This issue is postponed until the next meeting.

A resident was present and asked why Long Lake Improvement District did not get a check for the yearly donation. Wayne stated the Township never received the hours of inspections conducted.

9. Items to be added:

- a. Blue lake Dock:** Wayne said the wider the dock the more stable they are, and also the Sportsman Club wants to know what we have decided. Loren said he will call Minn Core on a 6 x32 foot dock. Motion by Wayne second Scott to approve the dock through Minn Core. Loren approved the motion.
- b. Fire Board:** Loren attended the Fire Board Meeting, and he said 5 Firefighters resigned last month. They were asked why and apparently, they were upset with AL, but they want another meeting.
- c. Margaret Lake:** It was a county ditch, in 2005 the County abandoned it. Kevin said it will be \$3,000 for Carpenter to see if he can find culvert otherwise its hourly after that. Wayne said the Board will have to go and look at it.
