- **1. Call to Order:** The Stanford Township meeting was called to order at 6:00 pm by Chairman Loren Daudt.

Motion by Scott second Wayne to approve the Treasurer's Report. Loren approved the motion.
- 6. Commissioner's Report: None.
- 7. Meeting Open to Public: Brytanie Dornfeld 26700 Zuni Street, regarding the Beaver and the easement. She asked about the easement. Wayne stated we have a permit to remove the beaver. She asked about the Township maintaining that road and possibly closing the minimum maintenance road. Wayne said that will not happen, the Township owns that road.

Frank & Judy Ellering, 24675 Tulip St., asked about paving Tulip Street. She wanted to know if we could put a culvert in. Loren said he thought we could replace the culvert so the water would flow better. Kevin will go check it.

Mark Schifsky, 27127 Bayshore Circle, stated there is a big dip in the road. Trees are hanging and 1 fell across the road over the weekend. The Board will have Kevin go look at it.

Casey Hedican, asked about a cannabis business he wants to start. Wayne had left the meeting at 6:30 pm so Loren told Casey that he should come to the August meeting when Wayne was present.
